

ARTICLES OF INCORPORATION  
OF  
VISIONARY TICKET PRODUCTIONS, INC.

ARTICLE I

NAME

The name of this corporation is Visionary Ticket Productions, Inc.

ARTICLE II

DURATION

This corporation shall have perpetual existence.

ARTICLE III

PURPOSE

This corporation is organized for the purpose of production or admission tickets and the transacting of any and all lawful business.

ARTICLE IV

CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of common stock.

ARTICLE V

PRE-EMPTIVE RIGHTS
