### Articles of Incorporation

We, the undersigned, as proper persons acting as incorporators of a corporation under the laws of the state of Florida, adopt the following articles of incorporation:

FIRST The name of the corporation is: STRING OF BALLOON'S, INC..

SECOND The period of its duration is: Until shareholders vote to dissolve the corporation..

THIRD The purpose of the corporation is: To sell and distribute balloons and other merchandise. Without limitations, engaging in retail. And any other lawful business.

FOURTH The aggregate number of authorized shares is: 100.

FIFTH The corporation will not commence business until at least 100 dollars have been received by it as consideration for the issuance of shares.

SIXTH Cumulative voting of shares of stock is authorized.

SEVENTH Provisions limiting or denying to shareholders the pre-emptive right to acquire additional or treasury shares of the corporation are: Only original shareholders will be allowed to purchase additional shares.

EIGHTH Provisions for regulating the internal affairs of the corporation are: All actions of the corporation must be voted on by the Board of Directors, which must give the officers the authority to act.
