ARTICLES OF INCORPORATION

OF

EAST-BLOC ENERGY HOLDING CORP.

The undersigned subscriber to these Articles of Incorporation, natural person competent to contract, does hereby associate to form a corporation for profit under the laws of the State of Florida. Corporate existence shall commence upon the filing of the Articles of Incorporation by the Department of State.

ARTICLE I

The name of this corporation is EAST-BLOC ENERGY HOLDING CORP...

ARTICLE II

General nature of the business or businesses to be transacted by this corporation is:

- (a) To do any and all of the acts and to exercise any and all of the powers now or hereafter authorized under the laws of the United States and the State of Florida to be done or exercised by corporations organized for profit.
- (b) To do any and all of the things herein set forth and everything necessary, suitable or proper for the accomplishment of any of the purposes, of the attainment of any of the objects, or the furtherance of any of the powers, of which shall appear to be conducive or expedient for the protection or benefit of this corporation to the same extent as natural persons might or could do, and in any part of the world as principal, agent, contractor, or otherwise, and either alone or in association with other corporations, firms, or individuals.

ARTICLE III

The maximum number of shares of stock authorized to be issued by this corporation is 1,000 shares of capital stock of the par value of ZERO (-0-) DOLLARS per share, all of which shall have the same rights and privileges. Each Share of capital stock shall entitle the holder thereof to one (1) vote at any stockholder's meeting and otherwise to participate in all such meetings and in the assets of the corporation. They shall be issued for such considerations as may be determined by the Board of Directors. They may be paid for in lawful money of the United States of

America, or in such property, labor or services. In the absence of fraud, the judgement of the Directors as to the value of property or services received in consideration for the issuance of stock shall be conclusive and binding upon all persons whomsoever.

The corporation shall have pre-emptive rights to purchase, subscribe for, or take any part of any stock or any part of the notes, debentures, bonds or other securities convertible into or carrying options or warrants to purchase stock of the corporation issued, optioned, or sold by after its incorporation. Any part of the capital stock and any part of the notes, debentures, bonds, or other securities convertible into or carrying options or warranties to purchase stock of the corporation authorized by this Certificate of Incorporation or by an Amended Certificate duly filed, may at any time be issued, optioned for sale, and sold or disposed of by the corporation pursuant to a resolution of its Board of Directors to such persons and upon such terms as may to such Board seem proper without first offering such stock or securities or any part thereof to existing stockholders.

ARTICLE IV

This corporation shall have perpetual existence unless dissolved according to law.

ARTICLE Y

The Board of Directors shall have complete charge of the business of the corporation and shall have the power to elect committees of the Board and to delegate to them, as well as to the officers of the corporation, such powers in the conduct of the corporation busins—a may be deemed advisable. The Board of Directors shall elect

the officers of the corporation, who shall consist of a President, Vice-President, Secretary and Treasurer and such officers as the Board of Directors may deem advisable and shall determine the compensation of such officers, including those who may also be directors. None of these officers are required to be stockholders of the corporation.
