


- FIRST: The name of this corporation is **NEXT FINANCIAL CORPORATION INC.**

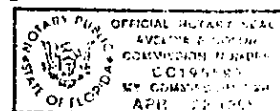
