The Name of the corporation shall be **HAWK PRIVATE INVESTIGATIONS OF FLORIDA, INC.**, whose principal office shall be located at 6230 Edgewater Drive, Building VI, Suite 1, Orlando, Florida 32810.

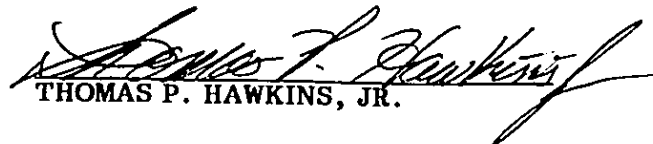

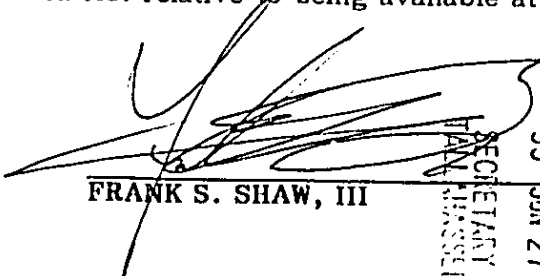
