ARTICLES OF INCORPORATION OF PAUL J. REILLY, M.D., P.A.

The undersigned incorporator to these article of incorporation, being duly licensed to practice medicine under the laws of the State of Florida, with the intention of forming a professional corporation under the Florida Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, The Under the laws of the State of Florida, adopts the following of incorporation for the corporation.

ARTICLE I: CORPORATE NAME

The name of the corporation is PAUL J. REILLY, M.D., P.A.

ARTICLE II. PRINCIPAL OFFICE

The address of the principal office and mailing address of the corporation is:

ARTICLE III: PURPOSE

The purposes for which the corporation is formed are:

- To engage in every phase and aspect of the practice of general medicine as a professional corporation. The sole and exclusive professional service to be rendered by the corporation is the practice of general medicine.
- (b) To invest funds of the corporation, and own real and personal property necessary for the rendering of the professional service specified above.
- (c) To do everything necessary, proper or convenient for the accomplishment of any of the purposes set forth in these articles, and to do every other act incidental to the corporate purposes which is not forbidden by the laws of the State of Florida or by the provisions of these articles of incorporation.
