ARTICLES OF INCORPORATION

OF

DALZUR STUD, INC.

We, the undersigned, hereby associate ourselves together for the purpose of becoming incorporated under the laws of the State of Florida, and do hereby adopt the following:

ARTICLES OF INCORPORATION

Article I

The name of the Corporation shall be DALZUR STUD, INC.

Article II

This corporation may engage in any activity or business permitted under the laws of the state of Florida.

Said share of stock shall be issued, sold or transferred only according to the By-laws of the Corporation for any indebtedness which may be due at any time by the holders of same to the Corporation, and such lien shall be superior to all liens of any character, and all assignments and transfers of stock of this Corporation shall be subject thereto.






