The undersigned, desiring to form a corporation for the purpose hereinafter stated under and pursuant to the laws of the State of Florida, do hereby declare as follows:

	ARTICLE I

The name of the	corporation shall be B, G & SON, INC
	ARTICLE II
	BUSINESS AND PURPOSE


