#### ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of TALA HOMES, INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

### ARTICLE I. NAME

## ARTICLE II. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

#### ARTICLE III. PURPOSE

This corporation is formed for the purpose of engaging in real estate development and investment and in all businesses incidental thereto and may engage in any activity or business permitted under the laws of the United States and Florida.

### ARTICLE IV. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 7,500 shares of common stock having a par value of \$1.00 per share.
