## ARTICLES OF DISSOLUTION OF R. J. EDMONDS AND ASSOCIATES, INC.

PURSUANT to Section 607.1403 of the Florida Business Corporation Act, this Corporation submits these Articles of Dissolution.

FIRST: The name of the Corporation is **R. J. EDMONDS AND ASSOCIATES, INC.**, which was duly incorporated on June 27, 1995, by the State of Florida.
