**ARTICLES OF INCORPORATION**

The undersigned incorporator, for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of this corporation shall be Raven Investigations, Inc.

**ARTICLE II - PURPOSE**

This corporation shall be organized for the purpose of engaging in any business which is lawful under the laws of the state of Florida.

**ARTICLE III - EXISTENCE**

This corporation shall have perpetual existence.

**ARTICLE IV - PRINCIPAL OFFICE**

The initial street address of the principal office of this corporation shall be Route 5, Box 658-6, West Julia Drive/Woodscreek Road, Perry, Florida, 32347.

**ARTICLE V - CAPITAL STOCK**

The authorized capital stock of this corporation shall consist of 100 shares of voting common stock having a par value of ten cents (10¢) each.

**ARTICLE VI - PREEMPTIVE RIGHTS, CUMULATIVE VOTING**

Holders of the capital stock of the corporation shall have the preemptive right to purchase any new shares of stock or securities, or rights to acquire stock or securities of the corporation. Cumulative voting shall not be allowed in the election of its directors or for any other purposes.

**ARTICLE VII - REGISTERED AGENT**

The registered agent of this corporation shall be James Edward Frostick, Jr. The address of the registered agent shall be Route 5, Box 658-6, West Julia Drive/Woodscreek Rd., Perry, Florida, 32347.

#### ARTICLE VIII - INCORPORATOR

The name and address of the incorporator is: James Edward Frostick, Jr., Route 5, Box 658-6, West Julia Drive/Woodscreek Rd., Perry, Florida, 32347.

#### ARTICLE IX - DIRECTORS

The number of directors for this corporation shall be set forth in the By-Laws. In no event, however, shall this corporation have less than one (1) or more than seven (7) directors. All members of the board of directors of this corporation shall consist of residents of Taylor County, Florida. The initial directors of this corporation are as follows:

#### ARTICLE X - COMPENSATION OF DIRECTORS

Compensation for the directors shall be approved by a majority vote of the shareholders.

#### ARTICLE XI - OFFICERS

All officers, agents, or employees as may be necessary shall be chosen in such a manner, for such time, and have such duties as may be described by the By-Laws or determined by the board of directors. Indemnification as provided hereunder shall continue as to a person who has ceased to be a director, officer, employee, or agent and shall inure to the benefit of his heirs, executors, administrators and assigns.
