OF

ARTICLE I
NAME

The name of this corporation is Sudler Insurance Services, Inc.

ARTICLE II
DURATION AND COMMENCEMENT OF EXISTENCE

This corporation shall commence on the date of filing of these Articles of Incorporation. This corporation shall have perpetual existence.

ARTICLE III
PURPOSE

This corporation is organized for the purpose of engaging in any activities or business permitted under the laws of the United States and the State of Florida.

ARTICLE IV
CAPITAL STOCK

This corporation is authorized to issue five thousand (5,000) shares of One Dollar (\$1.00) par value common stock.


**ARTICLE VIII


