

ARTICLES OF INCORPORATION
OF
THE MAK & T OF MANATEE COUNTY, INC.

I, COSTAS THOMAS, do hereby incorporate myself for the purpose of becoming a corporation for profit under Florida law.

ARTICLE I

The name of the corporation is THE MAK & T OF MANATEE COUNTY, INC..

ARTICLE II

This corporation may sell recreational vehicles and conduct other sales related activities. The corporation may also engage in other economic enterprises not prohibited by law.

ARTICLE III

The aggregate number of shares which this corporation is authorized to issue is Ten Thousand (10,000), all of which shall be common shares with a par value of One Dollar (\$1.00). Each shareholder of any class of stock of this corporation has full preemptive rights to purchase any unissued shares of the corporation. Each shareholder has full preemptive rights to purchase any shares held or owned by other shareholders of the corporation.

Each shareholder of any class of stock of this corporation is also entitled to full preemptive rights to purchase any corporate securities carrying rights of subscription to, and/or acquisition of, any unissued shares.

ARTICLE IV

The corporation shall have perpetual existence.

ARTICLE V

The business of the corporation will be conducted at 4240 Ironwood Circle, Building AA, #603, Bradenton, Florida 34209.

ARTICLE VI

The address of the registered office is: 4240 Ironwood Circle, Building AA, #603, Bradenton, Florida 34209. The name of the registered agent is: COSTAS THOMAS.

ARTICLE VII

The corporation's legal existence will begin on the first day it is legally qualified to conduct business in Florida.

ARTICLE VIII

The corporation may indemnify any officer, agent, or other representative, when reasonable, to the fullest extent permitted by law.

ARTICLE IX

The business of the corporation will be managed by the shareholders.


