The undersigned incorporator hereby adopts these Articles of Incorporation for the formation of a corporation under Plorids General Corporation Act.

### ARTICLE I

### MAKE

The name of this corporation is OLYMPIA RESIDENTIAL MORTGAGE CORPORATION.

### DUNATION

The duration of the corporation shall be perpetual.

Section 4. No Rights of Subrogation. Indemnification horsunder and under the Sylaws shall be a possonal right and the Corporation shall have no liability under this Article to any insurer or any person, corporation, partnership, association, trust or other entity (other than the hairs, executors or administrators of such person) by reason of subrogation, assignment or succession

by any other means to the claim of any person to indemnification hereunder or under the Corporation's Bylaws.
