The undersigned hereby establishes the following for the purpose of becoming a Corporation under the laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida providing for the formation, liability, rights, privileges and immunities of a Corporation for profit.

ARTICLE I

Name of Corporation

The name of this Corporation shall be SIU SERVICES, INC., with its principal office address: 2101 Corporate Bculevard, Suite 415, Boca Raton, Florida 33431.

ARTICLE II

Purpose

This Corporation is organized for the practice of law, to render legal services and services ancillary thereto, and for the purpose of transacting any or all lawful business.

ARTICLE III

Capital Stock

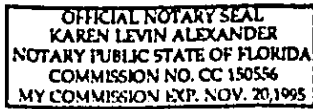


