## CERTIFICATE OF INCORPORATION

OF

## LONGWOOD GOLF CENTER, INC.

FIRST. The name of this corporation is LONGWOOD GOLF CENTER, INC.

SECOND. Its registered office in the State of Florida is to be located at 2527 Achilles Street, Port Charlotte, FL 33980, in the County of Charlotte. The registered agent in charge thereof is JOHN T. VASEY, at 2527 Achilles St., Port Charlotte. Florida, 33980. The corporation's principal office address is the same as shown above.

THIRD. The nature of the business and the objects and purposes proposed to be transacted, promoted and carried on, are to do any or all the things mentioned, as fully and to the same extent as natural persons might or could do, and in any part of the world. viz:
