ARTICLES OF INCORPORATION  
OF

ARTICLE I - NAME

The name of this corporation is Stop Destroying Our Planet Now, Inc. The principal address of this corporation is 125-55 Biscayne Blvd., N. Miami FL 33181.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV - CAPITAL STOCK
