CERTIFICATE OF INCORPORATION

OF

AIR SOURCE, INC.

FIRST. The name of this corporation is AIR SOURCE, INC.

SECOND. Its registered office in the State of Florida is to be located at 155 Coconut Street, Punta Gorda, FL 33980, in the County of Charlotte. The registered agent in charge thereof is CONNIE E. VASEY, at 155 Coconut St., Punta Gorda, Florida 33980. The corporation's principal office address is the same as shown above.

THIRD. The nature of the business and the objects and purposes proposed to be transacted, promoted and carried on, are to do any or all the things mentioned, as fully and to the same extent as natural persons might or could do, and in any part of the world, viz:

> The purpose of the corporation is to engage in any lawful act or activity for which corporations may be incorporated under the Florida General Corporation Act.

It is the intention that the objects, purposes and powers specified in the Third paragraph hereof shall, except where otherwise specified in said paragraph, be nowise limited or remitted by reference to or inference from the terms of any other clause or paragraph in this certificate of incorporation, but that the objects, purposes and powers specified in the Third paragraph and in each of the clauses or paragraphs of this charter shall be regarded as independent objects, purposes and powers.
