ARTICLES OF INCORPORATION

OF

GEORGE A. WHITE & CO., INC.

ARTICLE I. NAME

The name of this Corporation is GEORGE A. WHITE & CO., Inc., and the address is 4158 Barnsley Drive, Orlando, FLORIDA 32812.

ARTICLE II. TERM OF EXISTENCE

This Corporation shall exist perpetually.

ARTICLE III. NATURE OF BUSINESS



These Articles of Incorporation may be amended only by the vote or written consent of the holder of seventy-five percent (75%) of the outstanding shares entitled to vote.




