The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

The number of shares of stock that this corporation is authorized to have outstanding at any time is 1,000 shares of common stock, without par value.

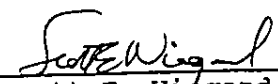

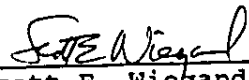

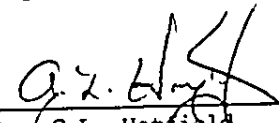
