The undersigned, acting as the incorporator of the corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

NAME: The name of the corporation is ANCHOR SEPTIC SERVICES, INC.

ARTICLE II

REGISTERED OFFICE AND REGISTERED AGENT: The street address of the initial registered office and principal office, being the same, is 668 KINLAW ROAD, ST AUGUSTINE, FLORIDA 32086.

The name of the initial registered agent is MARLENE M. CHILDERS.

ARTICLE III

DURATION: The corporation shall have perpetual existence.

ARTICLE IV
