

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I.

The name of this corporation is MOBI-CAN, INC.

ARTICLE II.

The main location where the company shall conduct its business is 3210 West Beaver Street, Jacksonville, Florida 32254.

ARTICLE III.

The duration of the corporation shall be perpetual.

ARTICLE IV.

The purpose of the corporation shall be to fabricate cans, paints, and welding for waste industry and for any and all other lawful purpose for which corporations for profit are incorporated under the laws of the State of Florida.

ARTICLE V.

The method of election of directors shall be as stated in the corporate by-laws.

ARTICLE VII.


