ARTICLES OF INCORPORATION

OF

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, hereby adopts the following Armicles of Incorporation.

EFFECTIVE DATE

(6 = 2 7 - 9 S ARTICLE I - NAME AND ADDRESS
