ARTICLE - NAME

The name of this corporation is ISLAND AIR TAXI, INC.



ARTICLE II - DURATION

This corporation shall commence on the date of filing of these Articles.

ARTICLE III

This corporation is organized for the purpose of transacting any and all lawful business, including the power;

a) To have perpetual succession by its corporate name.

and employees in accordance with Florida Stature 607.141.

- g) To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interest in, or obligations of, other or foreign corporations, associations, partnerships, or individuals, or direct or indirect obligations of the United States or of any other government, state, territory, governmental district, or municipality or of instrumentally thereof.
- h) To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as the corporation may determine, issue its note, bonds, and other obligations, and secure any of its obligations by mortgage or pledge of all or any of its property, franchises and income.
- i) To lend money for its corporate purposes, invest and reinvest its funds, and take and hold real and personal property as security for the payment of funds so loaned or invested.
- j) To conduct its business, carry on its operations, and have officers and exercise the powers granted by law within or without this state.
- k) To elect or appoint officers and agents of the corporation and define their duties and fix their compensation.
- 1) To make and alter bylaws, not inconsistent with these Articles of Incorporation or with the laws of Florida, for the administration and requlation of the affairs of the corporation.
