ARTICLES OF INCORPORATION OF

1. The Articles of Incorporation of the Corporation are hereby amended by deleting the first sentence of Article Six in its entirety and by substituting, in lieu thereof, the following:

**"ARTICLE SIX**

*The Board of Directors shall consist of no less than 1 (one) person and no more than 4 (four) persons."*

2. The foregoing amendment shall become effective as of the close of business on the date these Articles of Amendment are approved by the Florida Department of State and all filing fees then due have been paid, all in accordance with the corporation laws of the State of Florida.

3. The amendment recited in Section 1. above has been duly adopted in accordance with the provisions of §607.0821, .0704, .1003 and .1006, Florida Statutes, the shareholders and directors of the corporation having executed a written statement, dated September 16, 2003, manifesting his intention that the amendment be adopted.
