ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF

- 1. The name of the corporation prior to this Amendment is: **Trans World Career Builders, Inc.**
- 2. This Amendment changes the name of this corporation to **TransWorld Career Builders, Inc.**, and, therefore, old Article I of the corporation's Articles of Incorporation is hereby deleted and new Article I is added and shall read as follows:

ARTICLE I - NAME

The name of the corporation shall be: "TRANSWORLD CAREER BUILDERS, INC."

- 3. The foregoing Amendment was adopted by the board of directors of the corporation and by the shareholders of the corporation on April 13, 1999, by unanimous consent.
