## ARTICLES OF INCORPORATION

OF

# CLASSIC COURSE PUBLICATIONS,

#### ARTICLE I

## NAME

CLASSIC? COURSE The name of the Corporation shall be: PUBLICATIONS, INC.

#### ARTICLE II

#### PURPOSE AND NATURE OF BUSINESS

The general purpose and nature of the business to be transacted by this Corporation is (i) to lease or purchase such real and personal property as is necessary for the rendering of services; (ii) to engage in and transact any lawful business for which Corporations may be incorporated under the Florida General Corporation Act; and (iii) to do such other things as are incidental to the purposes of the Corporation or as are necessary or desirable in order to accomplish them.

In addition, the Corporation may also do the following: Invest funds in real estate, mortgages, stocks, bonds or any

other type of investments.
Contract indebtedness and borrow money, issue and sell or pledge bonds, debentures, notes and other evidences of indebtedness and transfer corporate property and execute such mortgages or other instruments to secure the payment of corporate indebtedness as is from time to time required.

Purchase the corporate assets of or merge or consolidate with any other domestic corporation engaged in the same character of

business.

Redeem, purchase, retain, sell and otherwise transfer its own

capital stock.

No purpose herein expressly stated shall limit the general purpose of the Corporation described in the first paragraphs of this Article II in any way.

## ARTICLE III

# CAPITAL STOCK

- The maximum number of shares of stock which this corporation is authorized to have outstanding at any time shall be TWENTY MILLION (20,000,000) shares of common stock having no par value.
- The capital stock may be paid for with property, labor or services, at a just valuation to be fixed by the incorporators, or by the directors at a meeting called for such purpose or at the

organizational meeting.

3. Property, labor or services may also be purchased or paid for with the capital stock at a just valuation of said property, labor or services, to be fixed by the directors of the company. Stock in other Corporations or going businesses may be purchased by the Corporation in return for the issuance of its capital stock and said purchase shall be on such basis and for such consideration and the issuance of so much of the capital stock as the Directors of the Company may decide.

#### ARTICLE IV

## PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this Corporation of the same kind, class of series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

# ARTICLE V

#### INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The street address of the initial registered office of this corporation is 10182 Plum Street, Palm Beach Gardens, Florida, 33410, and the name of the initial registered agent of this corporation at that address is Steve Pande, a resident of Palm Beach County, Florida.

#### ARTICLE VI

## INITIAL BOARD OF DIRECTORS

Initially, this corporation shall have no Directors. A Director will be elected/appointed at the first meeting of the stockholders, and thereafter this corporation shall have no less than (1) one Director constituting the Board of directors. The number of Directors may be either increased of decreased from time to time by the By Laws of the Corporation.

## **AMENDMENT**
