ARTICLE I--NAME

The name of this corporation is CAPALOU ENTERPRISES, INC.

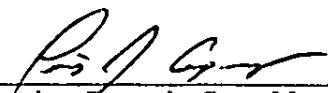
ARTICLE IX--INDEMNIFICATION

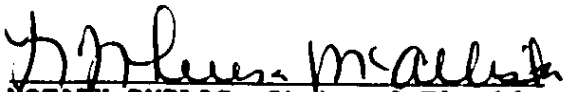

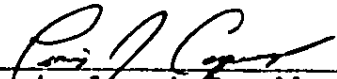

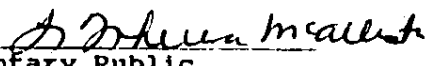
