ARTICLES OF INCORPORATION
OF

The undersigned incorporator to these articles of incorporation, being duly licensed to practice law under the laws of the State of Florida, adopts these articles to form a corporation under the Professional Service Corporation Act, Chapter 621, F.S., and other laws of the State of Florida.

ARTICLE I - NAME

The name of the professional service corporation is: Jonathan James Damonte, Chartered.

ARTICLE II - PRINCIPAL OFFICE

ARTICLE III - EXISTENCE

The professional service corporation shall have perpetual existence starting on the date these articles of incorporation are filed with the Florida Department of State, Division of Corporations.

ARTICLE IV - CAPITAL STOCK

The capital stock of the professional service corporation shall consist of 1,000 shares of common stock without par value. None of the shares of the professional service corporation may be issued to anyone other than an individual duly licensed to practice law in the State of Florida.

ARTICLE VII - RESTRICTIONS ON SHARES

The shareholders of this professional service corporation shall have the power to include in the bylaws, or by separate agreement adopted by a majority of the shareholders of the professional service corporation, any regulatory or restrictive provisions regarding the proposed sale, transfer, or other disposition of any of the outstanding stock of the professional service corporation by any of its shareholders, or in the event of the death of any of its shareholders. The manner and form, as well as the relevant terms, conditions, and details of the disposition, shall be determined by the shareholders of the professional service corporation; provided however, that such regulatory or restrictive provisions shall not affect the rights of third parties without notice of the provisions unless the existence of the provisions is noted on the certificate evidencing the ownership of the stock. No shareholder of the professional service corporation may sell or transfer stock in the corporation except to another individual who is eligible to be a shareholder of the professional service corporation, and the sale or transfer may be made only after it has been approved at a shareholder meeting called for that purpose. If any shareholder becomes legally disqualified to practice law in the State of Florida, or accepts employment that places restrictions or limitations on the continuous rendering of such professional services, then such shareholder's shares of stock shall immediately become subject to purchase by the professional service corporation in accordance with the bylaws adopted by the shareholders.
