THE UNDERSIGNED, acting as sole incorporator of A-Master Craftsmen, Inc., under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I

Name and Office

The name of the corporation shall be A-Master Craftsmen, Inc., and the corporate address shall be 540 N. State Road 434; Suite 16; Altamonte Springs, FL 32714.

ARTICLE III

Duration

The duration of the corporation is perpetual.

ARTICLE III

General Purposes

The purpose of the corporation is to engage in any acts or activities for which a corporation may be organized under Chapter 607 of the Florida Statutes.

ARTICLE IV

Shares

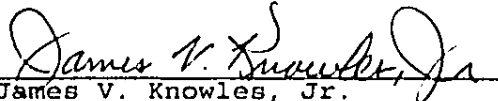
