ARTICLES OF INCORPORATION

of

ALL AMERICAN CAR CARE, INC.

The undersigned, a natural person of the age of eighteen (18) years, acting as incorporator of a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation.

ARTICLE ONE
