stock above designated.

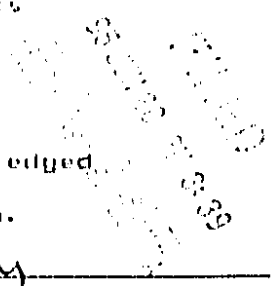
ARTICLE V - PREEMPTIVE RIGHTS


