ARTICLE I. CORPORATE NAME

The name of this Corporation is Grapevine Music, Inc.

ARTICLE II. NATURE OF BUSINESS AND POWERS

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III. CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is one hundred (100) shares of common stock without par value.

ARTICLE IV. TERM OF EXISTENCE

This Corporation shall have perpetual existence, commencing upon filing of these articles.

ARTICLE V. REGISTERED AGENT AND INITIAL REGISTERED OFFICE

The principal address and mailing address and the initial registered office of this Corporation are the same, and shall be: 184 Cloverdale Court, Ormond Beach, Florida 32174. The name of the initial registered agent is Edward Przestrzelski, and his address is 184 Cloverdale Court, Ormond Beach, Florida 32174. To signify acceptance of appointment as registered agent, the registered agent named in this article has executed his acceptance in this document as required by law.

The Board of Directors from time to time may move the Registered Office to any other address in the State of Florida.

ARTICLE VI. BOARD OF DIRECTORS

This Corporation shall have one (1) director initially. The number of directors may be increased or decreased from time to time by Bylaws adopted by the stockholders, but shall never be less than one.

ARTICLE VII. INITIAL DIRECTORS

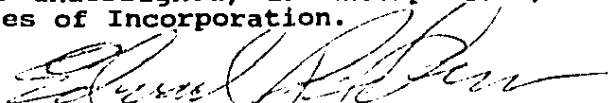
