The undersigned, for the purpose of forming a Corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation.

Article I - Name; Principal Office

The name of this Corporation is **MARMADE-EDDY ENTERPRISES OF ORLANDO, INC.** (the "Corporation"). The street address and the mailing address of the initial principal office of the Corporation shall be 2120 S. The date of commencement of corporate existence shall be upon filing. The Corporation shall have perpetual existence.

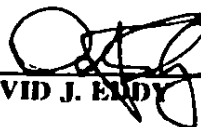
Article VI - Board of Directors
