ARTICLES OF INCORPORATION
OF
STUDIO V HAIRSTYLING, INC.

THE UNDERSIGNED, Monica Delores Young executed the following document as incorporator of the above named corporation, a corporation organized under the laws of the State of Florida, and all rights, duties and obligations of the undersigned as incorporator, and those of the corporation, are to be determined in accordance with the laws of the State of Florida.

ARTICLE I - NAME AND MAILING ADDRESS

a. The name of this corporation shall be: STUDIO V HAIRSTYLING, INC.

b. The mailing address of this corporation shall be at:

c. This corporation may have such other places of business in the State of Florida as the nature and progress of the business of the corporation shall, from time to time, render necessary and/or desirable. Said corporation shall have the power to conduct its business outside the State of Florida, or in any and all of the several States and Territories of the United States, including the District of Columbia, and any and all foreign countries and may have one or more offices in any of said places.

ARTICLE II - EXISTENCE

This corporation shall commence existence upon:

The general nature of the business to be transacted by the corporation and its objects and powers shall be as follows:


