**Profix, Inc.**

### **Article I**

The name of the corporation is: **Profix, Inc.**

### **Article II**

This corporation shall have perpetual existence.

### **Article III**

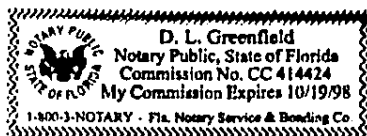

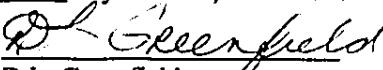
