Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, **C.C.I. EUROPE, INC.** adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is C.C.I. EUROPE, INC.
2. The original Articles of Incorporation for the corporation were filed on June 30, 1995, and assigned Charter No. P95000051424, and further amended on May 12, 1997.
3. By written consent executed on June 19, 2002 by the sole shareholder and sole director of the corporation, the sole shareholder and sole director have approved, authorized and directed that the Articles of Incorporation shall be amended to change the name of the corporation to "JEB/EUROPE, INC.". The amendment was approved by the sole shareholder and sole director, respectively, and the number of votes cast for approval was sufficient.
4. Article I of the Articles of Incorporation is hereby amended to read as follows:

ARTICLE I - NAME

The name of this corporation shall be JEB/EUROPE, INC.
