

Pursuant to Section 607.1403, Florida Statutes, we, the undersigned, hereby execute, acknowledge and file the following Articles of Dissolution for the purpose of recording the dissolution of Interserver, Inc., a Florida corporation for profit organized under the laws of the State of Florida, to wit:

**ARTICLE I - Name and Incorporation**

The name of the corporation is **INTERSERVER, INC.** (the "Corporation"), that was incorporated under Articles of Incorporation filed with the Florida Department of State on June 29<sup>th</sup>, 1995 and assigned document number P95000051425.

**ARTICLE II-Resolutions of the Shareholders**
