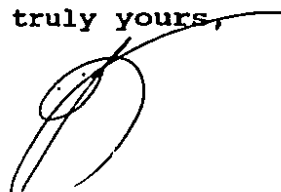

ARTICLE I

The name of the corporation is SCION INTERNATIONAL, INC. (the "Corporation").

ARTICLE II

The effective date of these Articles of Incorporation shall be July 1, 1995.

ARTICLE III

ARTICLE IV

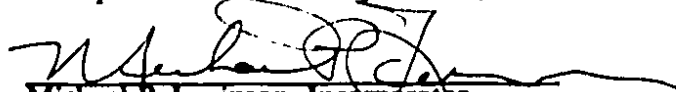

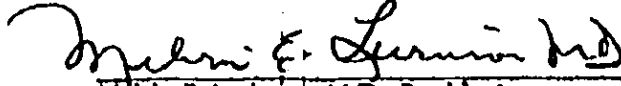
