ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I Name

The name of this corporation shall be Discount Vet Services, Inc.

Article II Duration

This Corporation shall have perpetual existence commencing upon filing with the Secretary of State.

Article III Purpose

This Corporation is organized for the purpose of transacting any or all lawful business.

Article IV Capital Stock

The aggregate number of shares which the Corporation shall have to issue is 10,000, all of which shall be common shares with par value of \$1.00.

Article V Preemptive Rights Granted

Each Shareholder of stock of the Corporation shall be entitled to full preemptive rights to purchase any unissued or treasury shares of the Corporation and any securities of the Corporation convertible into or carrying a right to subscribe to or acquire shares of any such unissued or treasury shares.

The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors.

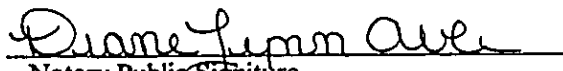
