### ARTICLES OF INCORPORATION

OF

### MEGA STAR, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I

The name of the corporation is MEGA STAR, INC.

#### ARTICLE II

This corporation shall be formed and its existence shall be in perpetuity.

### ARTICLE III

The purposes for which the corporation is organized and the nature of its business is the production and distribution of musical recordings, booking of bands and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

# ARTICLE IV

The aggregate number of shares that the corporation is authorized to issue is One Thousand Share (1,000.00), all of which shall be common shares and shall have a par value of one dollar (\$1.00) per share. The Corporation is authorized to issue only one class of stock.

### ARTICLE V
