ARTICLE I - NAME

The name of this corporation is: UROLOGY ASSOCIATES OF NORTH CENTRAL FLORIDA, P.A.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE
