ARTICLE OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do herby adopt the following articles of indepporation:

ARTICLE ONE

The name of the corporation is NORTEC MEDICAL SERVICE, INC.

ARTICLE TWO

The duration of the corporation is perpetual.

ARTICLE THREE

The general purpose for which the corporation is organized are:

1.- To engage in the business of RENTAL/SALES MEDICAL SUPPLIES.

- 2.- To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act.
