ARTICLES OF INCORPORATION
of
INTERNATIONAL WASTE & RECYCLING MANAGEMENT, INC.

ARTICLE I-NAME

The name of the corporation is INTERNATIONAL WASTE & RECYCLING MANAGEMENT, INC.

ARTICLE II-DURATION

This corporation shall have perpetual existence commencing on the date of filing of these Articles with the Department of State.
