Pursuant to the provisions of section 617.1006, Florida Statutes, PAUL L. WEAN, P.A. adopts the following articles of amendment to its articles of incorporation:

FIRST: The amendment adopted is as follows:

ARTICLE I
NAME

The name of this corporation is ~~PAUL L. WEAN, P.A.~~ **WEAN & MALCHOW, P.A.**

ARTICLE II
PURPOSES

This corporation is organized for the purpose of delivering professional legal services and related services to the public and transacting any and all lawful business permitted for such a professional service corporation under chapters 607 and 621 of the Florida Statutes.
