

ARTICLE ONE NAME

The name of the corporation is **TIDEWATER DEVELOPMENT** CORPORATION OF NORTHWEST FLORIDA, INC..

ARTICLE TWO CORPORATE DURATION

The duration of the corporation is perpetual.
