## ARTICLE I - NAME

The name of this corporation is

FALCON EXPRESS CORPORATION 7270 NW 12th Street, PH-9 Miami, Florida 33126

#### ARTICLE II - DURATION

This corporation shall have perpetual existence.

#### ARTICLE III - PURPOSE

## ARTICLE XIII - MANAGEMENT OF CORPORATION BY SHAREHOLDERS

All corporate powers shall be exercised by or under the authority of, and the business and affairs of this corporation shall be managed under the direction of, the shareholders of this corporation.

#### ARTICLE XIV - POWERS

### ARTICLE XV - DIRECTORS RESIDENCY AND COMPENSATION


