

CERTIFICATE OF INCORPORATION

This is to hereby certify that we, RAFAEL EDUARDO MANRIQUE, VIVIAN LEE CHUNG AND BRIAN MATTHEW VILLA, do hereby associate ourselves into a corporation, under and by virtue of the statutes of the State of Florida.

- 1) The name of the corporation is Rafael Eduardo Manrique, Inc.
- 2) The location of the principle office in this State is at: 3639 Silver Lace Ln., #84, Boynton Beach, Palm Beach County, FL 33436.
- 3) The name of the registered agent therein and in charge thereof, upon whom process against this corporation may be served, is Rafael Eduardo Manrique.
- 4) The objects for which this corporation is formed are: to engage in local and regional transportation services, and the doing of any other business and contracting work incidental to or connected with such work.
 - 4a) The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful business purposes which may become necessary, profitable or desirable for furtherance of the corporate objectives expressed above.
 - 4b) The corporation shall also have power to conduct its business in all its branches, have one or more offices, and unlimitedly to hold, purchase, mortgage and convey real and personal property in any State, Territory or colony of the United states and in any foreign country or place.






