KNOW ALL MEN BY THESE PRESENTS: That the undersigned incorporator acknowledges and files this Certificate for the purpose of forming a corporation under aws of the State of Florida.

### NAME OF CORPORATION

FIRST: The name of the Corporation shall be UNITED FOR POSITIVE ACTION OF DADE COUNTY. INC.

### OBJECTIVE OR OBJECTS OF CORPORATION
