The undersigned incorporators, being natural persons competent to contract for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt these Articles of Incorporation for the described corporation.

ARTICLE I: NAME      The name of the proposed corporation shall be BEACHSIDE INVESTIGATIONS, INC.

ARTICLE II: PURPOSE      The general purpose of this corporation is to carry out the business of a licensed private investigator and to have the power to transact any lawful business allowed for corporation for profit by the laws of the State of Florida and the United States.


